



**BLADEx ANNOUNCES QUARTERLY DIVIDEND PAYMENT
FOR SECOND QUARTER 2025**

Panama City, Republic of Panama, August 4, 2025 - Banco Latinoamericano de Comercio Exterior, S.A. ("Bladex" or the "Bank"), announced today its Board of Directors' approval of a quarterly cash dividend of US\$0.625 per share corresponding to the second quarter of 2025.

The cash dividend is payable September 3, 2025 to the Bank's stockholders as of August 15, 2025 record date.

As of June 30, 2025, Bladex had 37,231,194.86 shares outstanding of all classes.

Bladex, a multinational bank originally established by the central banks of Latin-American and Caribbean countries, began operations in 1979 to promote foreign trade and economic integration in the Region. The Bank, headquartered in Panama, also has offices in Argentina, Brazil, Colombia, Mexico, the United States of America, and a Representative License in Peru, supporting the regional expansion and servicing of its customer base, which includes financial institutions and corporations.

Bladex is listed on the NYSE in the United States of America (NYSE: BLX), since 1992, and its shareholders include: central banks and state-owned banks and entities representing 23 Latin American countries, commercial banks and financial institutions, and institutional and retail investors through its public listing.
